Thank you for your email of 12 December 2022 to the Department of Corrections – Ara Poutama Aotearoa, requesting information about rehabilitation and training programmes in 2021/22. Your request has been considered under the Official Information Act 1982 (OIA).

Corrections aims to provide people with the right intervention at the right time to encourage them to address their needs.

Each person's rehabilitative and reintegrative pathway is unique and based on many considerations including the nature of their offending, their risk of re-offending, their motivation to change, their physical and mental wellbeing, and the support they have around them. In prisons, case managers work with people one-on-one to identify their rehabilitation needs and match these with available programmes to be completed throughout their sentence. Whanau, iwi partners, psychologists, programme facilitators, mental health clinicians, education tutors, industry instructors, reintegration service providers, and many other staff and external partners also play an important role in this process.

We make every effort to provide rehabilitation interventions and treatment to people in prison before their release date or first parole hearing. However, this is a complex exercise - participants need to be suitable for the intervention, motivated to participate and located in the right place. We also need to balance parole eligibility dates with the capacity of the units where services are provided as well as the staff who are available to provide that service, noting that there is a significant shortage of psychologists in New Zealand and internationally.

Corrections provides health services, mental health and addiction programmes, cultural support services, educational opportunities, vocational and employment training, motivational sessions, offence-focused programmes, wrap-around whānau support, reintegration services, intensive residential programmes, and transitional accommodation support.

I would like to request updated figures for the cost/completion rates of rehabilitation and training programmes for the 2021/22 year, using the OIA C149693 as a reference point (i.e. I would like the content of this table updated for 21/22 year!)

## Appendix Two – Cost of rehabilitation programmes in 2021/22

## Table note:

- Attends are the number of unique people who attended at any point during the financial year. If a person attends the same programme more than once they are counted once.
- Starts count the number of starts during the financial year. If a person starts the same programme more than once they are counted multiple times.
- Completes represent the number of people who have completed during the financial year. If a person completes the same programme more than once they are counted multiple times.
- Some programmes are not scheduled to start and finish evenly throughout the year so caution is needed when comparing attends with completes within the financial year.
- Our previous response listed, the Māuri Toa Rangatahi [youth programme] and Te Whare [youth programme targeted at burglary offending]
  programmes, which were consolidated and replaced with Te Whare Hāpai Tangata that began to be delivered in 2021. This was to ensure that the
  expanded programme [eligibility] is fully subscribed, and that longer-term reductions on reoffending amongst youth and young adults are achieved in
  both prison and the community as there is greater accessibility and impact with a wider range of young people.
