**Notes for tables:**

- Figures have been sourced from and reviewed by regional managers. Due to improvements to reporting practices, they may differ from figures previously published elsewhere.
- Figures in Table One represent each person who participated in RTW at any point during the financial year. People will be counted more than once if they participated in RtW over multiple years or at different prisons.
- Some figures in Table Two are withheld in cases where there was there only a single RtW participant for the financial year period, to protect the privacy of natural persons, in accordance with section 9(2)(a) of the OIA.
- People participating in RtW are paid market rates as determined by their employer and the length and hours of employment can vary for each person. As such, we would urge caution drawing any conclusions from the figures provided regarding regional differences or average rate of earning.
- Figures are also not directly comparable between prisons due to differences in population sizes and demographics.
- When reviewing figures for the 2019/20 and 2020/21 periods, note that some people's ability to participate in RtW has been impacted by COVID-19 restrictions and associated impacts on a range of industries.
