Thank you for your email of 18 July 2023 to the Department of Corrections – Ara Poutama Aotearoa, requesting information about recruitment and resignations of Corrections staff. Your request has been considered under the Official Information Act 1982 (OIA). I would like to apologise for the delay in this response reaching you.

As you are aware, on 25 July 2023 we contacted you to explain that due to the way this data is stored, we would be required to review every unique job title within Corrections in order to provide you with the information you requested. As that would require significant substantial collation we consulted with you to determine if the scope of your request could be narrowed. Thank you for confirming you would like information for corrections officers in the first instance.

Like many other organisations and businesses around the country, we have been facing ongoing challenges related to our staffing levels in recent years. We fully acknowledge the pressure this has placed on staff working in prisons, which is why we are making a concerted effort to recruit, retain and train frontline staff.

This includes launching a new recruitment campaign, strengthening our recruitment processes, improving our onboarding processes, implementing new rosters which provide our staff with better work/life balance and help them to avoid fatigue, and continuously working to improve staff safety. Our staff have also been carrying out recruitment activities in their local communities (for example, information evenings for people interested in working with us).

There has been an increase in the number of job applications received for new corrections officers, with more than 5,800 applications received since October 2022. Since that time we have also recruited 540 people into frontline roles, with many more in the recruitment pipeline.

You requested:

 How job applications has Corrections received in 2023 so far in the period of January to July? After vetting, how many of those were processed? How many offers were issued in relation to these and in what roles?

Corrections received 5,035 job applications between 1 January 2023 and 31 July 2023 for corrections officer roles. Of these, 4,389 of those have been processed, with 330 employment offers made.

 How many employees has Corrections recruited in 2023 so far in the period of January to July? / Can you please provide a breakdown of the roles that have been recruited in this same period?

483 corrections officers have been appointed from January to July 2023. Please note some of these appointments were from applications prior to January 2023.

 How many employees did Corrections recruit in the same period between January to July in 2022? / Can you please provide a breakdown of the roles that have been recruited in this same period?

From January to July 2022, 243 corrections officers were appointed.

How many employees did Corrections recruit in 2022 in total? / Can you
please provide a breakdown of the roles that have been recruited in this same
period?

Corrections appointed 447 corrections officers in 2022.
