Tēnā koe

Thank you for your email of 6 January 2023 to the Department of Corrections – Ara Poutama Aotearoa, requesting information regarding Hōkai Rangi Whakataetae Kapa Haka. Your request has been considered under the Official Information Act 1982 (OIA).

You requested:

Since its implementation in 2020, how many prisoners around New Zealand, per year, have taken part in Hōkai Rangi Whakataetae Kapa Haka? Organised by prison.

In 2020, Corrections inter-prison kapa haka competition was developed, with the input from the Rautaki Māori Team at Corrections' National Office. Members of the team included staff who are kapa haka exponents, with experience in managing and coordinating kapa haka teams. The first competition, which has since continued yearly, was marked by staff, Māori service providers, hapū and iwi representatives either attending as spectators or performing with the site's team.

Participants perform in front of their families, staff and local iwi and, in many cases, share the stage with Corrections staff. Those taking part said it gave them a greater sense of connection to their identity, culture and language.

As a result, the competition has strengthened the relationship between our staff and the participants, surrounded by those involved in tikanga Māori, and in many cases restored and strengthened iwi links.

People taking part have grown in confidence as a result and the intent is that whānau and iwi stay connected after release. This will lead to greater reintegration, which will in turn result in reduced re-offending and safer communities.

In 2022, for the first time, participants had the opportunity to gain NZQA credits through Te Kura. These credits count towards their educational qualifications.

Please note that despite COVID-19 and staff resourcing issues, the *Hōkai Rangi Whakataetae Kapa Haka* has been able to run for three years consecutively. However, it is important to review the figures in the context of intermittent periods of COVID-19 restrictions and staffing shortages which had an impact on the ability to deliver this initiative. Figures also include those assisting off-stage, which include people in our custody, staff & Māori service providers.

Please find the requested information in the table below, which provides the number of people in prison who participated, broken down by prison and year, between 2020 and 2022.
